The base goal projection after weighting is as follows:

- Total Weighted DBE Availability: **\$24,074,982**
- Total for All Trades: **\$187,110,230**

Dividing the weighted DBE totals by the total estimate for all trades gives a base DBE availability figure for the projects anticipated during the goal-setting period. This figure is expressed as a percentage and serves as the basis for the three-year overall goal.

Base of DBE Goal: 12.9%

While there is sufficient historical data on DBE participation the DBE goals were not met in three of the five years of historical data. Therefore, an adjustment to the base goal as calculated is not warranted.

Furthermore, there are no applicable disparity studies for the local market area or recent legal case information from the relevant jurisdictions to show evidence of barriers to entry or competitiveness of DBEs in the market area that is sufficient to warrant making an adjustment to the base goal.

Breakout of Estimated "Race and Gender Neutral" (RN) and "Race and Gender Conscious" (RC) Participation

Columbus Regional Airport Authority (John Glenn Columbus and Bolton Field) will meet the maximum feasible portion of the overall goal by using race neutral means of facilitating DBE participation.

- 1. Arranging solicitations, times for the presentation of bids, quantities, specifications, and delivery schedules in ways that facilitates DBE, and other small businesses, participation;
- 2. Providing assistance in overcoming limitations such as inability to obtain bonding or financing;
- 3. Providing technical assistance and other services;
- 4. Carrying out information and communications programs on contracting procedures and specific contract opportunities;
- 5. Implementing a supportive services program to develop and improve immediate and long-term business management, record keeping, and financial and accounting capability for DBEs and other small businesses;
- 6. Providing services to help DBEs and other small businesses improve long-term development, increase opportunities to participate in a variety of kinds of work, handle increasingly significant projects, and achieve eventual self-sufficiency;
- 7. Establishing a program to assist new, start-up firms, particularly in fields in which DBE participation has historically been low;
- 8. Ensuring distribution of DBE directory, through print and electronic means, to the widest feasible universe of potential prime contractors;
- 9. Assist DBEs and other small businesses, to develop their capability to utilize emerging technology and conduct business through electronic media.

Columbus Regional Airport Authority (John Glenn Columbus and Bolton Field) estimates that in meeting the established overall goal of 12.9%, it will obtain 1.0% from RN participation and 11.9% through race conscious measures.

This breakout is based on:

Columbus Regional Airport Authority (John Glenn Columbus and Bolton Field) holds meetings open to all small businesses that are realistically expected to result in at least 1.0% additional DBE participation during the time frame of this triennial goal; therefore, 1.0% of the 12.9% goal is anticipated to be met via race-neutral means and the remaining 11.9% through race-conscious participation.

Columbus Regional Airport Authority (John Glenn Columbus and Bolton Field) will adjust the estimated breakout of race neutral and race conscious DBE participation as needed to reflect actual DBE participation (see §26.51(f)) and track and report race neutral and race conscious participation separately. For reporting purposes, RN DBE participation includes, but is not necessarily limited to the following: DBE participation through a prime contract obtained through customary competitive procurement procedures; DBE participation through a subcontract on a prime contract that does not carry a DBE goal, DBE participation on a prime contract exceeding a contract goal, and DBE participation through a subcontract from a prime contractor that did not consider a firm's DBE status in making the award.
